## SECTION 3 - HAZARDS IDENTIFICATION

### EMERGENCY OVERVIEW

### POTENTIAL HEALTH EFFECTS

**INHALATION:** High concentrations are irritating to the respiratory tract; may cause headache, dizziness, nausea, vomiting and malaise. Chronic overexposures, or a single large dose, may cause sensitization and subsequent reaction to a later exposure to methacrylates at levels well below the TLV

**SECTION 4 - FIRST AID MEASURES**

**INHALATION:** Remove affected person to fresh air; provide oxygen if breathing is difficult; if affected person is not breathing, administer CPR and seek emergency medical attention.
